Overview: The Executive Director is in charge of overseeing our strategic vision and leading business decisions to ensure overall stability and growth. Duties include collaborating with our leadership teams, implementing strategic plans for the center's development and managing relationships with our on-site and larger community.

The ideal candidate will be a kind, warm-hearted individual who values harmony and is comfortable working in a dynamic environment that welcomes a variety of spiritual teachers and practitioners, guests, staff members and volunteers.

Job Responsibilities:

- Work in conjunction with the Spiritual Program Coordinator and Team to support LMB's
 mission, programs and spiritual teachers. Follow the five Buddhist lay precepts when onsite**.
- Collaborate with the Board of Directors to identify, create and implement strategic plans to actualize business objectives.
- Identify, recruit, train and develop a talented team of employees who can lead critical departments and manage strategic business functions.
- Monitor company operations and ensure employees and business practices comply with regulatory and legal requirements.
